## **Incoming Syndicated Reciprocal Listing Instructions**

*An enhanced reciprocal listing application will allow your listing to be entered onto BAREIS MLS and will be visible in BAREIS syndication, products and to data share MLSs. You will not have access to the BAREIS MLS or BAREIS MLS information.*

If you are a member of **METROLIST, MLS LISTINGS INC., SFARMLS, BridgeMLS, BAY EAST, CCAR, Sutter/Yuba, or Nevada County** you already have direct access to BAREIS to enter listings. No additional forms or fees are required. You may access the BAREIS MLS® system by clicking the BAREIS logo under the single sign-on link from your MLS (For Paragon users, click on Resources). ### **For all other Reciprocating Associations:**

BAREIS will enter a listing for you once we receive the following information submitted by **The Listing Agent or the Listing Agent's Association**:

- A completed **BAREIS Listing Input Sheet** (You may obtain copies from your local MLS or at our website (<http://bareis.com/listing-input>). Please be sure to fill out all fields with an asterisk.
- A **Syndicated Reciprocal Application**, found below.
- A Check or Credit Card Authorization in the amount of **\$150.00** payable to **BAREIS**.
- A copy of the **listing profile** as it appears on **your MLS System**.

Once we receive these four items, we can enter your listing into BAREIS. When your listing is input, you will receive a print-out confirmation for your review and approval. Once we receive your approval, your listing will be activated in BAREIS.

Please remember to submit all changes to the listing in writing and include a printout of the requested change as it appears in your home MLS system (including final sale information). By placing a listing into BAREIS you are required to report the final sold status to BAREIS MLS.
